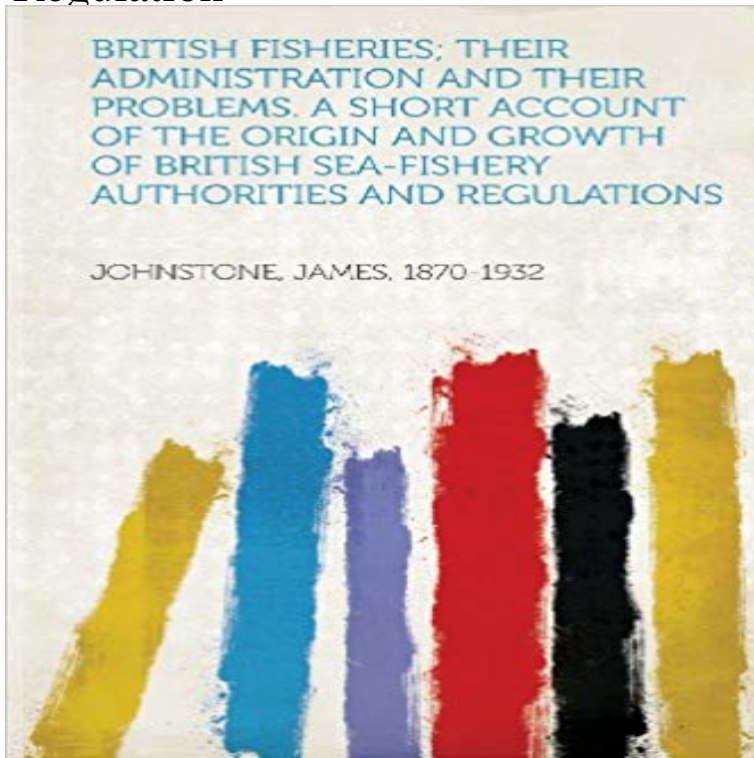


# British Fisheries; Their Administration and Their Problems. a Short Account of the Origin and Growth of British Sea-Fishery Authorities and Regulation
