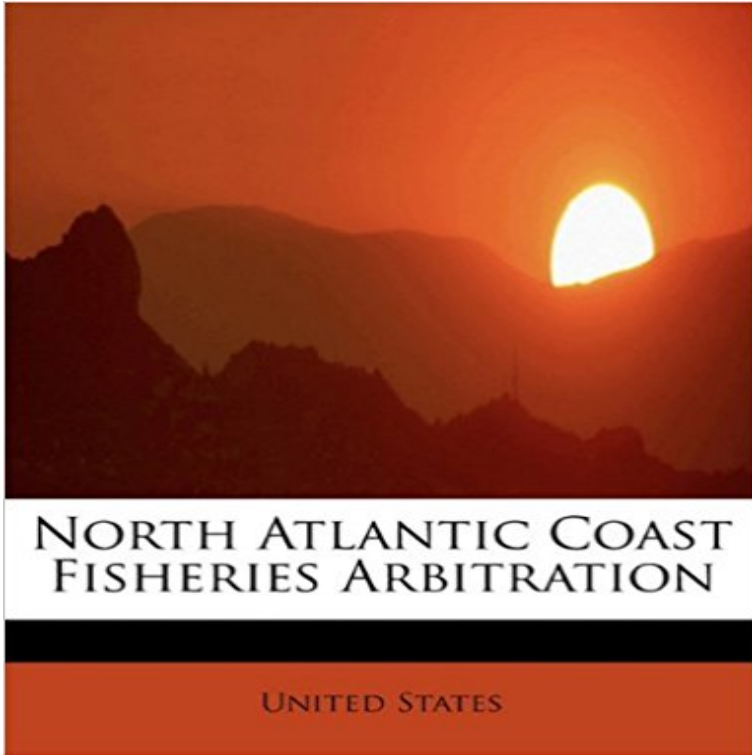


North Atlantic Coast Fisheries Arbitration
