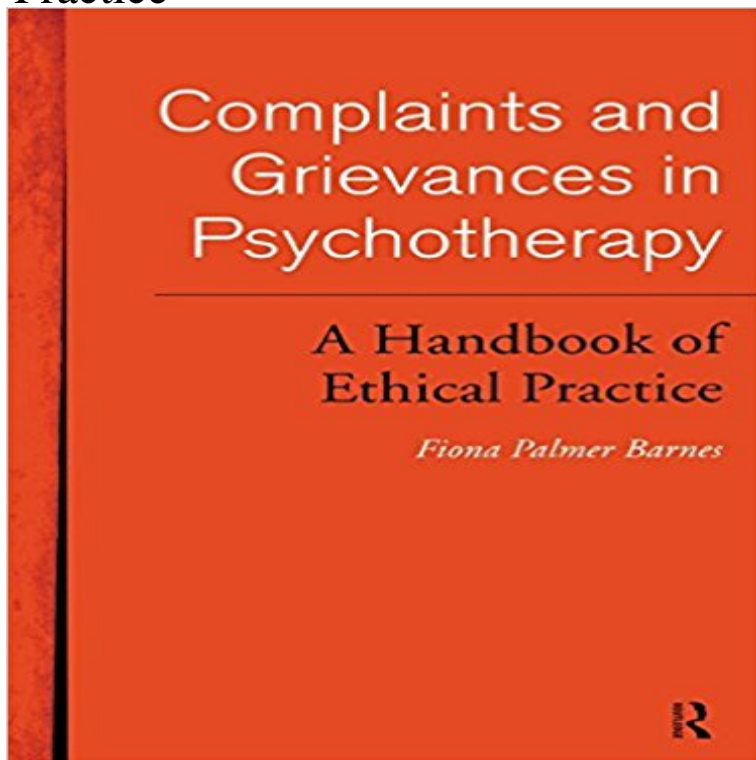


Complaints and Grievances in Psychotherapy: A Handbook of Ethical Practice
