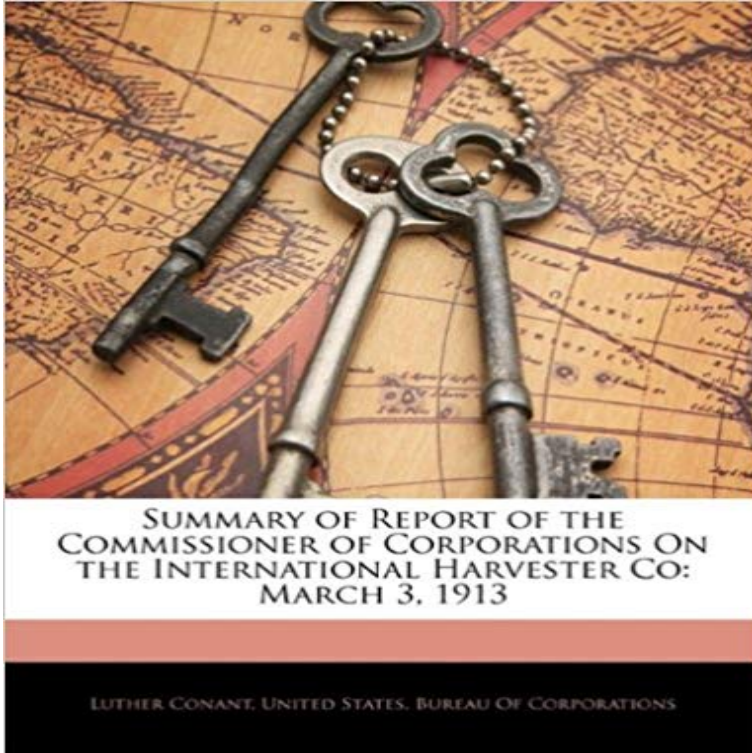


## Summary of Report of the Commissioner of Corporations On the International Harvester Co: March 3, 1913
